II. Main achievements: Strengthened legal framework

LEGAL FRAMEWORK:

- **Proposals for the amendment on the Law No. 270/2018 on the unitary salary system** in the budgetary sector were submitted to the Ministry of Finance and the State Chancellery for NBS staff motivation involved in the process of **Work Program** drafting legislation, including on the alignment of national legislation with the EU acquis
- The certification of **Other National Authorities (ONAs)** according to the Regulation approved through GD No. 51/2022 was launched. In total **14 requests** of different public institutions-candidates to get ONA status.
- The **Statistical for 2024 and 2025** supplemented with an additional chapter on **Experimental Statistics**, that included 8 statistical works

THE AVAILABILITY OF SDG INDICATORS:

- Online **platform for SDG indicators** launched <https://statistica.gov.md/en/sustainable-development-goals-183.html> according to the National framework for monitoring the implementation of the 2030 Sustainable Development Agenda (approved by the Government 953/2022)
 - Out of the national set of indicators (337 indicators) - 271 are available (80%), 66 - Not available (20%);
 - 53% of the Global set of indicators are fully available, 5% are partially available, and 42% are not available or not relevant
 - Out of EU 102 indicators **26 indicators are included in the national set** of indicators, **8 – are partially** in the national set
- Methodology for the compilation of **Multidimensional poverty index** (1.2.2) developed, experimental estimations made and presented;
- Building NBS staff capacity and practical skills in reporting on **SDG indicators 2.1.1 (undernourishment) and 2.1.2 (food insecurity)** based on national data;
- Calculation of **SDG indicator 2.3.1** carried out;
- Experimental estimation of **SDG indicator 3.8.2** for Europe;
- **Revision** of the national M&E framework – ongoing.

II. Main achievements: Strengthening operational framework

QUALITY MANAGEMENT:

- ❖ Single Integrated Metadata Structure (SIMS) was used to document about 20 surveys;
- ❖ The policy on the revision of official statistics was developed according to ESS guidelines on revision policy for Principal European Economic Indicators (Eurostat, edition 2013);

EXTEND THE ACCESS AND USE OF ADS AND PRIVATELY HELD DATA:

- Improved policy and procedures were put in place for better protection of personal data;
- In 2022 the NBS got the ISO certificates: **ISO/IEC 27001:2013** on information security and **ISO/IEC 27701:2019** on the protection of personal/confidential data, reconfirmed in January 2024;
- The access to individual data, especially for Population and Housing census to more than 15 administrative registers and two private data sources was extended;
- Access to administrative data sources for the production of business, demographic and wages statistics extended;

II. Main achievements: Modernized technical & technological infrastructure

REDESIGN OF ICT SYSTEM:

- **Regulation** approved through the GD No. [38/ 2024](#) **on the functioning and organisation of the Information System for production of demographic and social statistics** (approved by GD no. [604/2022](#) - transposing the provisions of 5 EU regulations and the European Statistics Code of Practice) - it enables the access to alternative data sources and efficient production of statistics
- **Regulation** approved through the GD No. [980/2023](#) **on the functioning of the information systems: the "Public Depository of Financial Statements"** (approved by GD no. 590/2022 - in compliance with Directive 2013/34/EU on annual financial statements and European best practices);

INFORMATION SYSTEMS (IS) WERE DEVELOPED and subsequently specifications have been developed on:

- IS Population and Migration Statistics, Population and Housing Census - sub-systems of the **Demographic and Social statistics** Information system;
- IS Public Depository of Financial Statements;
- Census technical infrastructure put in place;

NEW DATA COLLECTION based on modern technologies:

- Computer-Assisted Personal Interviews (CAPI) method implemented for data collection for the Labour Force Surveys and Population Census - using CSPro, and for Household Budget surveys – using Survey Solutions;
- Geospatial platform development (under development);
- Digitalization of e-reporting by legal entities, establishments;

Concepts used

- **Usual residence, place of birth, country of citizenship,** and others - adopted by Census National Committee in 2023, which are in compliance with the definitions as per
 - *UN Principles and Recommendations for Population and Housing Censuses (2017)*
 - *Recommendations of the Conference of European Statisticians, UN Economic Commission for Europe on RPL round 2020*
 - *Regulation (EC) No. 763/2008* of the EU Parliament and the EU Council regarding RPL and 4 other regulations implementing this Act
- Use of *International Recommendations on Internally Displaced Persons Statistics (2020)*

- Reduction in the number of **field staff** 2024- 5600, compared to 2014- 14500
- Use of **electronic devices**
- Data collection method: **combined**
 - Direct - personal interviewing using a mobile electronic device (**CAPI** – for regular population and collective living quarters – 8 April-7 July, in fixed sections - 26 June - 07 July) and web (**CAWI** – for diplomats, 1-7 July)
 - Indirect – use of **administrative and private data** sources.
- Use of a **geographic information system** (GIS) at the stage of preparing the PHC, collecting data and disseminating the results
- Inclusion of some topics related to household's **agricultural activities**
- **External audits** conducted in 2020-2021, Methodology for generating a unique statistical identifier for **pseudonymizing of personal data, PDP Policy** in place
- **ISO/IEC 27001:2013** on information security and **ISO/IEC 27701:2019** on the protection of personal/confidential data.

PHC Questionnaires

- Are fully in line with the Eurostat and UN Recommendations for the 2020 census round
- Reflect all the requirements of the Census Regulation (EC) No 763/2008 - all core topics
- Were widely consulted with important groups of data users (public authorities, academia and civil society, development partners, local public administration authorities and defenders of human rights)
- Available in 7 languages (Romanian, Russian, English, Ukrainian, Gagauz, Romani, Bulgarian)

III. Population and Housing Census (PHC) 2024: Lessons learned

- Good **planning in advance** secures from unexpected risks and incidents.
- As much as possible **testing of CAPI/CAWI applications** before conducting PHC is never too much.
- **Capacity building** of temporary census personnel is more effective when it covers as many **practical exercises** as time allows.
- Use of **information technology for human resources management** (recruiting, contracting, retribution) saves a lot of time.
- Census promotion and communication through the **voice of partners** (academia, civil society, sociologists, media, vloggers, etc.) is helpful for tailored communication with **difficult-to-approach groups of population**.

III. Population and Housing Census (PHC) 2024: Follow-up

PHC – actions to follow:

- **Census data processing** (undergoing)
- **Assessing the quality of census data**
- **Dissemination**
- **Promoting the use of census results** for policy making, research activities, informing society (information seminars, workshops, research projects, etc.)
- **Electronic storage** of pseudonymized census data, ensuring confidentiality and data protection in accordance with the terms established in art. 17 of Law no. 231/2022

PHC 2024 dissemination plan:

- Preliminary results - to be disseminated in **6 months** (December 2024)
- Brief final results (*thematic informative notes*) - in **12 months** (July 2025)
- Final results (*thematic results, the application for visualisation census results, the development of GIS maps, infographics, the preparation of microdata for research purposes, including public files (Public Use Files), etc.*) - in **18 months** (December 2025)

III. Population and Housing Census (PHC) 2024: Assistance

The **EU technical assistance** project "*Support for the NBS in conducting the 2024 PHC*" worth of 2 000 000 EUR, with co-financing of 75 000 EUR from UNFPA



The family of **UN agencies**, through the Office of the UN Resident Coordinator in Moldova and other donors.



Assistance included:

- EU expertise (technical experts)
- purchase of 3 000 tablets for data collection
- communication and promotion campaign addressing difficult to approach categories of people (*refugees, ethnic minorities, adult population through children, disabled, etc.*)
- temporary census personnel capacity building.

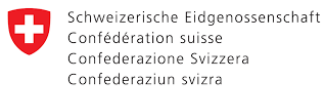
